**ORDER No. 65 OF THE MINISTER OF INTERNAL JUSTICE AND ADMINISTRATION
of 28 December 2018 amending the order on the establishment of a state budgetary
unit named**

National Institute for Local Self-Government

Based on Article 12(1)(1) and (2) of the Public Finance Act of 27 August 2009 (Journal of Laws of 2017, item 2077, as amended), it is ordered as follows:

§ 1 In the Annex to Order No. 36 of the Minister of Administration and Digitization of 3 September 2015 on the establishment of a state budgetary unit named "National Institute for Local Self-Government" (Dz. Urz. Min. Ad. and Cyf. pos. 56, Dz. Urz. Min. Spraw Wew. i Ad. of 2016, pos. 58 and of 2018, pos. 8) in § 4 in section 1, after point 4, points 4a and 4b shall be added in the following wording:

"4a) an independent position for fulfilling tasks related to personal data protection;

4b) an independent position for company archives;"

§ 2 The Regulation shall enter into force on the day of its publication.

**ORDER No. 6 OF THE MINISTER OF INTERNAL JUSTICE AND ADMINISTRATION
of 2 February 2018 amending the order on the establishment of a state budgetary unit
named
National Institute for Local Self-Government**

On the basis of Article 12(1)(1) and (2) of the Act of 27 August 2009 on public finance (Dz. of 2017, item 2077 and of 2018, item 62), it is ordered as follows:

§ 1. in the Annex to Order No. 36 of the Minister of Administration and Digitization of 3 September 2015 on the establishment of a state budgetary unit named "National Institute of Local Self-Government" (Official Gazette of the Minister of Administration and Digitization, item 56 and Official Gazette of the Minister of Internal Affairs and Administration of 2016, item 58), the following amendments shall be made:

1) in § 2:

a) in section 2 in item 6 the full stop shall be replaced by a semicolon and item 7 shall be added in the following wording:

"7) implementation of other educational and training activities within the scope indicated by the Minister of Internal Affairs and Administration"

b) the following paragraph 3 shall be added after paragraph 2:

"3. The supervising authority may commission the Institute to perform tasks other than those indicated in paragraphs 1 and 2, in particular concerning educational and training activities related to the functioning of public administration."

2) in § 4, section 1, points 5-7 shall read:

"5) The team for cooperation with external entities and promotion;

6) The team for the implementation of projects, analyses and publishing activities;

7) The team for educational and training activities."

§ 2 The Ordinance shall enter into force as of the date of its publication.
